## SUMMARY ANNUAL REPORT

## INDIANA/ KENTUCKY/ OHIO REGIONAL COUNCIL OF CARPENTERS SUPPLEMENTAL UNEMPLOYMENT BENEFIT FUND

This is a summary of the annual report for the Indiana/ Kentucky/ Ohio Regional Council of Carpenters Supplemental Unemployment Benefit Fund, (EIN #34-1237479 PN# 501) for the year ended April 30, 2014. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$332,594, which included \$41,644 in administrative expenses and \$290,950 in benefit payments to participants. A total of 381 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$110,289 as of April 30, 2014, compared to \$256,271 as of April 30, 2013. During the plan year, the plan experienced a decrease in its net assets of \$145,982. This decrease includes the unrealized appreciation/(depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost assets acquired during the year. The plan had total income of \$186,612, including earnings from investments of \$7,028, gains from investments of \$8,762, and employer contributions of \$170,822.
