## SUMMARY ANNUAL REPORT

## IBEW LOCAL UNION #306 401 (K) WAGE REDUCTION RETIREMENT FUND

This is a summary of the annual report for the IBEW Local Union #306 401(k) Wage Reduction Retirement Fund, (EIN #31-1516748) for the year ended December 31, 2013. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$171,822, which included \$61,281, in administrative expenses, deemed distributions of \$5,801, and \$104,740 in benefits paid to participants and beneficiaries. A total of 292 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$11,342,920 as of December 31, 2013, compared to \$8,734,807 as of December 31, 2012. During the plan year, the plan experienced an increase in its net assets of \$2,608,113. This increase includes unrealized appreciation/ (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,779,935 including employee contributions of \$751,451 other income of \$43,627, and income from investments of \$1,984,857.
