SUMMARY ANNUAL REPORT FOR THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS LOCAL 688 - RETIREMENT PLAN

This is a summary of the annual report of the International Brotherhood of Electrical Workers Local 688 - Retirement Plan, 34-1536966, for the year ended May 31, 2013. The annual report has been filed with the Internal Revenue Service as required under the Employee Retirement Income Security Act of 1974.

GENERAL INFORMATION

The Plan is a qualified multi-employer defined benefit plan covering substantially all members of International Brotherhood of Electrical Workers Local 688. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The Plan is not covered by the Pension Benefit Guaranty Corporation.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$8,381,509 as of May 31, 2013, compared to \$7,285,160 as of May 31, 2012. During the plan year the plan experienced a increase in its net assets of \$1,096,349. This increase includes unrealized appreciation/depreciation in the value of plan assets; that is, the difference between the value of plan assets at the end of the year and the value at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,494,885 including employer contributions of \$354,521, other income of \$25 and net investment income of \$1,140,339.

Plan expenses were \$398,536. These expenses included \$58,851 in net administrative expenses and \$339,685 in benefits paid to participants and beneficiaries.
