## Important Notice From Mahoning & Trumbull County Building Trades Insurance Fund About Your Prescription Drug Coverage and Medicare

### Who Does This Notice Apply To:

**All Normal Retiree Members and/or Dependents covered under the Mahoning & Trumbull County Building Trades Insurance Fund who are eligible for Medicare.** These persons will need this information to help decide whether or not, and when, to enroll in one of the Medicare prescription drug plans being offered since prescription drug coverage is not available through the Mahoning & Trumbull County Building Trades Insurance Fund.

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with Mahoning & Trumbull County Building Trades Insurance Fund and about your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

There are three important things you need to know about your current coverage and Medicare's prescription drug coverage:

1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
2. Mahoning & Trumbull County Building Trades Insurance Fund has determined that the prescription drug coverage offered by the Mahoning & Trumbull County Building Trades Insurance Fund is, on average for all plan participants, **NOT** expected to pay out as much as standard Medicare prescription drug coverage pays. Therefore, your coverage is considered Non-Creditable Coverage. This is important because, most likely, you will get more help with your drug costs if you join a Medicare drug plan, than if you only have prescription drug coverage from the MAHONING & TRUMBULL COUNTY BUILDING TRADES INSURANCE FUND. This also is important because it may mean that you may pay a higher premium (a penalty) if you do not join a Medicare drug plan when you first become eligible.
3. Because prescription drugs are **NOT** covered by the Plan for Normal Retirees and Dependents eligible for Medicare your coverage is non-creditable, you have decisions to make about Medicare prescription drug coverage that may affect how much you pay for that coverage, depending on if and when you join a drug plan. Read this notice carefully - it explains your options.

### **When Can You Join A Medicare Drug Plan?**

You can join a Medicare drug plan when you first become eligible for Medicare and each year from November 15th through December 31st.

### **When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?**

Since the coverage under MAHONING & TRUMBULL COUNTY BUILDING TRADES INSURANCE FUND is not creditable, depending on how long you go without creditable prescription drug coverage, you may pay a penalty to join a Medicare drug plan. Starting with the end of the last month that you were first eligible to join a Medicare drug plan but didn't join, if you go 63 continuous days or longer without prescription drug coverage that's creditable, your monthly premium may go up by at least 1% of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (penalty) as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following November to join.

You will also get it before the next period you can join a Medicare drug plan and if this coverage through MAHONING & TRUMBULL COUNTY BUILDING TRADES INSURANCE FUND changes.
