## SUMMARY ANNUAL REPORT

## **SEPTEMBER 30, 2010**

TO PARTICIPANTS OF THE PLAN - This is a summary of the annual report for Mahoning & Trumbull County Building Trades Insurance Plan, EIN 34-0746419, Plan number 501, for the period October 1, 2009 to September 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Mahoning & Trumbull County Building Trades Insurance Plan has committed itself to pay the following types of claims incurred under the terms of the Plan: Health, Short Term Disability, Life

BASIC FINANCIAL STATEMENT - The value of plan assets after subtracting liabilities of the plan totaled \$13,560,508 as of September 30, 2010, compared to \$11,431,710 as of October 1, 2009. During the plan year, the plan experienced an increase in its net assets of \$2,128,798. The increase includes unrealized appreciation or depreciation in the value of plan assets; that is the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,148,696, which included employer contributions of \$5,484,860, employee contributions of \$864,940, a net realized gain of \$196,366 from the sale of the assets, and earnings from investments of \$602,530. Plan expenses were \$5,019,898. These expenses included \$294,958 in administrative expenses and \$4,724,940 in benefits paid to participants and beneficiaries.
