SUMMARY ANNUAL REPORT

OPERATIVE PLASTERERS AND CEMENT MASONS PROFIT SHARING ANNUITY PLAN

This is a summary of the annual report for the Operative Plasterers and Cement Masons Profit Sharing Annuity Plan, (EIN #34-1736454) for the year ended June 30, 2013. The annual report has been filed with the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$3,005,056, which included \$246,638 in administrative expenses and \$2,758,418 in benefits paid to participants and beneficiaries. A total of 4,272 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$46,235,037 as of June 30, 2013, compared to \$41,465,082 as of June 30, 2012. During the plan year, the plan experienced an increase in its net assets of \$4,769,955. This increase includes unrealized appreciation/ (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$7,775,011 including employer contributions of \$3,546,177, gain from investments of \$4,226,584, and other income of \$2,250.
