# For OHIO CONFERENCE OF PLASTERERS & CEMENT MASONS HEALTH & WELFARE FUND

This is a summary of the annual report of the OHIO CONFERENCE OF PLASTERERS & CEMENT MASONS HEALTH & WELFARE FUND, EIN 31-6051539, Plan No. 501, for period May 01, 2012 through April 30, 2013. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Insurance Information

The plan has a contract with Fidelity Security Life Insurance Company to pay stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending April 30, 2013 were \$236,991.

### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$12,078,764 as of April 30, 2013, compared to \$9,440,036 as of May 01, 2012. During the plan year the plan experienced an increase in its net assets of \$2,638,728. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$13,151,355, including employer contributions of \$10,429,766, employee contributions of \$2,076,756, realized losses of (\$21,206) from the sale of assets, earnings from investments of \$381,418, and other income of \$284,621.

Plan expenses were \$10,512,627. These expenses included \$730,155 in administrative expenses, and \$9,782,472 in benefits paid to participants and beneficiaries.
