## SUMMARY ANNUAL REPORT

This is a summary of the annual report for the PLUMBERS AND PIPEFITTERS LOCAL 94 HEALTH & WELFARE PLAN (EIN 34-6594978, Plan No. 501), for the period May 1, 2012 to April 30, 2013. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$10,631,446 as of April 30, 2013, compared to \$10,134,083 as of May 1, 2012. During the plan year, the plan experienced an increase in its net assets of \$497,363 This increase includes net unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$5,118,743. This income included employer contributions of \$3,859,237, employee contributions of \$636,326, realized gains of \$13,655 from the sale of the assets, earnings from investments of \$395,720, and other income of \$213,805. Plan expenses were \$4,621,380. These expenses included \$324,596 in administrative expenses and \$4,296,784 in benefits paid to participants and beneficiaries.
